- Pistol: .22 rimfire repeating pistol. NO magnum ammunition. Targets: NRA Official B-2, B-3 targets.
- Eligibility: Any adult competitor may enter. NRA membership is encouraged but not required.
- Categories: None
- Classifications: None Awards: None
- Entries: Limited to 16 competitors for each tournament, which is the range capacity for the time allotted. Individual Entries: Post entries are preferred and will be accepted, up to the range capacity provided such entries will not require additional relays. Entries may also be made by submitting the enclosed Registration and Entry Card accompanied by a check or money order payable to the local match sponsor.
