This competition is a **NRA Registered Match**. All regulations for registered matches will govern.

The 2019 NRA International Free Pistol Sectional National Indoor Pistol Championships are being fired at Sectional Tournaments throughout the United States. All local challenges and protests are to be resolved on the match site according to procedures outlined in Section 16 of the NRA International Pistol Rule Book. Each individual competitor and team firing in a Sectional will automatically be entered in the National Championship at no additional cost. **Note:** All fired target must be retained by sponsor two weeks after the bulletin is posted on the NRA website.

**Competition Date:** Sunday, February 10<sup>th</sup>, 2019

**Rules:** Current NRA International Pistol Rules.

**Competition Open to:** All competitors. Individual or team may enter only one NRA International Free Pistol Sectional during 2019. Membership in the NRA is encouraged but not required in order to participate in this match. Tournament officials may not compete in the Sectional at which they are officiating.

Teams will consist of three (3) firing members as defined in Section 2. **Team members must be designated before the individual matches commence. The individual match score will be used for the team score. The team match is not a fired match.**

NRA Sectional Registration Fees include entry into the 2019 NRA Indoor Pistol Championships.

**Match Fee:** \$10.00 per competitor.

**Team Matches:** \$10.00 per team. (team matches are not a fired match).

**Entries Close:** Advance individual match entries must be received no later than Monday, February 4<sup>th</sup>, 2019. Team entries must be made prior to the start of any team member's firing in the individual match.

**Post Entries:** No post entry fee will be charged.

**Competition Capacity:** Match is limited to 16 competitors. Entries will be accepted up to the limit. Entries received after the limit has been reached will be returned.

**Firing Starts:** 1<sup>st</sup> Relay: 09:00 AM – 11:00 AM.  
2<sup>nd</sup> Relay: 11:30 AM – 01:30 PM.

**Distance:** 50 Feet.

**Targets:** NRA Official: Free Pistol B-11

**Schedule & Course** **Match No. 1 - Free Pistol:** Unlimited sighters and sixty record shots in 120 min. Fired in 7 stages, 17 minutes per stage. 1st stage unlimited sighters. 2<sup>nd</sup> thru 7<sup>th</sup> stage is 10 shots per target.

**Match No. 2** Free Pistol Team, (team match is not a fired match).

**Challenges:** A challenge fee of \$1.00 will be charged for each challenge made.

**Classification:** The NRA International Pistol Rules, Section 19-Classification, shall govern for both individuals and teams. Each competitor must exhibit a valid classification card or Temporary Score Record Book prior to the start time. Unclassified competitors will fire in the Master class

**Category:** Open, Woman, Junior, Junior Woman, Senior, and Grand Senior.

**Souvenir Award:** NRA will provide a participation pin for each competitor.

**NRA Sectional Awards:** Schedule will be posted on site.

**Local Individual Awards:** Schedule will be posted on site.

**Local Team Awards:** Schedule will be posted on site.
